- **3** Even with the decreasing use of dental amalgam, dental practices are expected to discharge 2 tons of mercury through vacuum lines in 2040.

Amalgam buckets: In addition to wastewater management, the EPA Dental Rule requires that all items contaminated with amalgam residue be recycled. This includes chairside traps, amalgam capsules, and vacuum filters, as well as excess amalgam and removed restorations. For all of these items, Solmetex provides safe, approved amalgam storage and shipping buckets with prepaid return shipping and a certificate of recycling. The buckets are available in 4 sizes.



Lead buckets: Lead from film, sterilization indicators, and lead aprons must be carefully disposed of according to the EPA's regulations. Solmetex offers recycling services and approved shipping buckets in 2 sizes to recycle lead foil, bitewings, autoclave indicators, sterilization tape, and lead aprons.



Biohazard/sharps buckets: Similar to its amalgam and lead disposal containers, Solmetex provides containers for proper collection and disposal of biohazardous waste, including contaminated sharps, sponges, gloves, towels, gauze, and bibs. Systems for 5-gallon and 20-gallon quantities are available.

Chemical filters: If a practice is still using radiographic film, Solmetex has a photo-chemical disposal solution, including easy-to-install manual and automatic filters. California-specific filters also are available.

Enroll through the Solmetex Compliance Center, where 24/7 online access to certificates of recycling and other documents are readily available.

Delivery schedules and product choices are easily customized at any time through a simple user portal. Participating in the Solmetex Maintenance Program requires no contract or fees, and the dentist can cancel the program at any time.

All Solmetex collection containers and amalgam buckets come with shipping labels and instructions to streamline the containers' quick, safe return for EPAapproved recycling. With the Solmetex Maintenance Program, replacing a container is just as simple as filling and shipping one.
