In the interest of maintaining dealer relations, Solmetex has developed a corporate policy related to all print advertising, including internet. Printed pricing of Solmetex products cannot be less than 5% of the suggested retail price of the product.

Solmetex is in no way restricting or dictating pricing structure for you as a dealer. If a customer contacts you directly and you wish to lower your price at that time, Solmetex respects your right as a dealer to sell our products at any price.

As an approved dealer an initial opening order of \$10,000 USD will be required and must include a combination of our current products. A minimum annual sales goal of \$25,000 USD in the calendar year must be obtained to remain in good standing. If your sales goal is not achieved within this period, your account will be reviewed and may be subject to closure.

### **CANADA ONLY**

Sales into Canada are handled through an import/export firm to ensure the integrity of the mercury recycling program according to Canadian law. Solmetex asks that all dealers respect this arrangement to ensure that no environmental regulations are compromised. Therefore, Solmetex does not permit any selling or advertising of our amalgam separator into Canada from non-Canadian dealers.

The same applies to Canadian dealers wishing to sell into the USA. No Canadian dealer may sell into the USA without the written consent of Solmetex LLC. Selling or posting our products for sale in the USA via Amazon or any third parties is prohibited.

Violation of these Solmetex Corporate Policies will result in the termination of the violating party as a dealer for the Solmetex product lines.
