SHOCK TREATMENTS ARE IMPORTANT. HERE'S WHY:

- Extreme Variability in Source Water Quality Erodes the effectiveness of maintenance treatments and allows bacteria to recolonize waterlines.
- Human Error

Common in protocol driven routines. Monthly or quarterly shock cycles reduce the impact of undetected protocol breaches that would otherwise lead to a test failure.

Water Test Failures

Your response will always be the same, shock immediately and retest ASAP.

WATER TESTING IS IMPORTANT. HERE'S WHY:

- Not Testing is Not Knowing If you don't assess the bacterial content in your dental unit, how do you know you're compliant?
- Liability Claims

Patient injury caused by questionable infection control practices can open the door for lawsuits*. Consistent and properly documented water testing provides the basis for a legal defense against claims of negligence should the quality of your dental unit water be called into question.

• Legal Requirements

In some states, clinicians are now required to prove the bacterial content in dental unit waterlines meets the <500 CFU/ml drinking water standard.
